## RESOLUTION TO FILL VACANCY OF TOWNSHIP OFFICE RC§503.24

(FISCAL OFFICER)

Whereas Cynthia Chapman, the duly elected Fiscal Officer of Bazetta Township, Trumbull County, Ohio resigned from office on the close of busines 4:00pm March 31, 2021; and

Whereas the office of Fiscal Officer is deemed vacant by reason of said resignation;

**NOW THEREFORE, BE IT RESOLVED,** that <u>Stacy A. Marling</u>, Elector of the Township be and hereby is appointed to the Office of Fiscal Officer, Bazetta Township, Trumbull County, Ohio, to fill the unexpired term of office of such vacancy, and to hold such Office until a successor is duly elected and qualified; and

**BE IT FURTHER RESOLVED,** that said appointment is effective <u>April 5<sup>th</sup></u>, <u>2021</u> and upon compliance of the following legal requirements of holding the public office of Township Fiscal Office:

As the appointed Fiscal Officer you are required to appear before the Chairman of the Bazetta Township Board of Trustees or other official authorized to administer oaths, to take the oath of office (by swearing or affirming) as prescribed by Sections 3.22 and 3.23 of the Ohio Revised Code and Section 7 of Article XV, Ohio Constitution, and to post bond or in the alternative give proof of a Dishonesty and Faithful Performance of Duty Insurance Policy as provided in RC§3.061, the Bond issued by a surety or insurance Policy issued by a licensed insurance provider/underwriter approved by the Board of Trustees as required by Section 507.03 of the Ohio Revised Code.¹ The Bond or Dishonesty and Faithful Performance Duty Insurance Certificate must be delivered to the Trumbull County Treasurer, who is responsible for maintaining and safeguarding the Bond or Insurance Certificate.
