#### RESOLUTION - BAZETTA TOWNSHIP

WHEREAS natural, technological, and man-made hazards can affect Bazetta Township; and

WHEREAS significant structural, historical, and economic losses could result from an occurrence of a natural, technological, or man-made hazard events; and

WHEREAS undertaking mitigation projects during pre-disaster periods could decrease the total losses Bazetta incurs as a result of said hazard occurrences.

AND WHEREAS the Bazetta Township Trustees has a strong interest in reducing losses from future hazard occurrences; and

WHEREAS the hazard mitigation plan is a federal and state requirement to maintain eligibility for hazard mitigation funding, and, by that requirement, must be updated a minimum of every five years; and

WHEREAS a cooperative, joint effort is a proven, efficient way to plan for and reduce hazard susceptibility in all government jurisdictions in Trumbull County, Ohio.

THEREFORE the Bazetta Township Trustees has partnered with the county to update the existing *Trumbull County Multi-Jurisdictional Hazard Mitigation Plan* in an effort to further identify, define, and characterize the hazards affecting Bazetta Township as well as to continue identifying and prioritizing projects that could lessen hazard vulnerability.

## RESOLUTION TO PROCEED TO LEVY A TAX IN EXCESS OF THE TEN MILL LIMITATION

Resolution No. # 4 -21 ( Renewal Fire Tax Levy 0.8 mills)

The <u>Board of Trustees</u> of <u>Bazetta Township</u>, Trumbull County, Ohio, met in <u>Regular</u> session on the \_\_\_\_ day of June, <u>2021</u>, at the office of said Board, with the following members present:

Trustee Theodore Webb Trustee Frank Parke Trustee Robert McBride

Trustee Parke moved the adoption of the following Resolution:

WHEREAS, on the 25th day of May, 2021, the Board of Trustees passed and adopted Resolution No.#121-21 declaring the necessity, for the purposes set forth in RC \$5705.19(I), to levy a tax in excess of the ten-mill limitation under RC \$5705.03, RC \$5705.19(I) and RC \$5705.191 at the rate of 0.8 mills for each one dollar of valuation, which amounts to \$0.08 for each one hundred dollars of valuation, for five years; and

WHEREAS, the Trumbull County Auditor has certified to the Board of Trustees that the dollar amount of revenue to be generated by the tax levy during the first year of collection is  $\frac{94,731.00}{100}$ , based upon the current assessed valuation of the Township of  $\frac{100}{100}$ ,  $\frac{100}{100}$ , be it

RESOLVED, by the <u>Board of Trustees</u> of <u>Bazetta Township</u>, Trumbull County, Ohio, all members elected thereto concurring, that the Board desires to proceed with the submission of the question of a <u>renewal</u> tax in excess of the ten mill limitation for the benefit of Bazetta Township, to the electors of <u>Bazetta</u>

Township pursuant to pursuant to RC \$505.37(A), RC \$5705.03, RC \$5705.19(I) Fire and RC \$5705.191 for the purpose of providing and maintaining fire apparatus, appliances, buildings, or sites therefore, or sources of water supply and materials therefore, or the establishment and maintenance of lines of fire alarm telegraph, or the payment of permanent, part-time or volunteer firefighters personnel or fire fighting companies to operate the same, including the payment of firefighter employer's contributions required under RC §742.34 of the Ohio Revised Code or to purchase ambulance equipment, or to provide ambulance, paramedic or other emergency medical services operated by a fire department or fire fighting company, at a rate not exceeding 0.8 mills for each one dollar of valuation, which amounts to \$0.08 for each one hundred dollars of valuation for a period of five (5) years, commencing tax year 2021 collection year beginning 2022, which tax will be voted upon and levied on the total unincorporated area of Bazetta Township, which is wholly located in Trumbull County, Ohio.

BE IT RESOLVED that the provisions of said tax levy be submitted to the electors of said <u>Bazetta Township</u>, in the <u>general</u> election to be held on the <u>2nd</u> day of <u>November</u>, 2021; and

BE IT FURTHER RESOLVED that said tax levy be submitted to the electors under the authority of Ohio Revised Code, Sections 5705.03, 5705.19(I) and 5705.191; and

RESOLVED that the Fiscal Officer of this Board of Trustees of Bazetta Township be, and she is hereby directed to certify a copy of this Resolution to the Board of Elections, Trumbull County, Ohio, not less than ninety days prior to the election and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.
