Statement of the Case

In 2018, Grievant, Nathan Greathouse, and Jake J. Abbott were full-time Patrol Officers with the Bazetta Township Police Department located in Trumbull County, Ohio. In 2018, the position of Sergeant became available which is a higher ranking position and a higher paying position than the position of a Patrol Officer. Both Grievant and Abbott timely applied for the Sergeant position.

The Employer promoted Jake J. Abbott to fill the position of Sergeant.

Grievant/Nathan Greathouse, a Patrolman, timely filed a grievance stating that the Grievant, and not then Patrolman Jake J. Abbott, should have been promoted to the position of Sergeant. Grievant processed through the steps, but the Employer denied the grievance of Greathouse through all of the steps.

The Grievant/Nathan Greathouse timely and properly invoked Arbitration. An Arbitration hearing was held April 20, 2022, where both Advocates presented well prepared cases. Both Advocates timely submitted briefs with well prepared arguments.

Statement of the Facts

A sergeant position became available for the Bazetta Police Department. The Bazetta Township Trustees and the Chief of Police set a deadline for applications to be submitted. The deadline set for applications was a very short time from the time when the position was posted by the township. One of the requirements for the application was the taking the educational course, *First Line Supervision Training*.

The Bargaining Unit introduced evidence and argued that The Chief of Police "Manipulated the Promotional Process to the Grievant's Disadvantage." See, Bargaining Unit's post hearing brief. Because of the short notice to attend the class for *First Line Supervision Training*, Grievant could not attend this class before the deadline for the submission of the application for the sergeant position.

Grievant was required to pay for the course himself, because the department did not have any funds left for education or training. However, Grievant completed the course. When Grievant did complete the course, Grievant promptly notified the Chief of Police.

The Grievant's Advocate provided evidence and arguments that the Police Chief provided a copy of the registration form to Jake Abbott, and advised Jake Abbott, the other applicant, to sign up for it because it would be a requirement for promotion. The Chief of Police did not provide Grievant with a copy of the registration form, nor did the Chief of Police provide Grievant with advice that the Chief provided Jake Abbott.

This Arbitrator finds the following facts in italics submitted by Grievant's Advocate to be true:

"Additional methods Chief Hovis used to deny the promotion to the Grievant included the Chief himself placing only a select few training certificates in the application packet submitted by the Grievant, accepting 5 letters of recommendation regarding Abbott, most of which were dated after the application deadline had passed (UE 2, p. 11,13,14), and allowing the submission of a letter in support of Abbott signed by Sergeant Herlinger and 4 members of the department (that was also dated past the deadline for submission of the applications.)UE 2 p. 10. These actions were prohibited by the terms of the CBA for being untimely and for not being requested in the application. JE1 Article 11 Section 1. Chief Hovis did not limit himself to tampering with the application process, he actively tried to pick the next Sergeant by approving training for Abbott then denying that same training to the Greathouse.

The first time the Van Meter class was brought up as a "requirement" for promotion was when the September 2018 posting was posted. The Grievant, who had requested the class in 2017 and did so again immediately after the posting of the promotion, as forced to pay for the class himself, as Chief Hovis informed him that the budget was allocated to a photography class and evidence room management class, both for Abbott. UE 7. The Grievant went to the class after paying for it himself. Strangely, the certificate that he placed in the Chief's mailbox so that it could be added to his personnel file never made it to his personnel file.

Perhaps the most damning testimony about the former chief Hovis came from his own brother Paul Hovis, who was a Trustee at the time of the promotion. Paul Hovis

testified that the Grievant did not get a "fair shake" and that Chief Hovis did not mention that he had told Abbott to sign up for the class, nor did he mention that Greathouse had many years of being OIC for his shift. Moreover, Trustee Hovis testified that his brother was known to hold a grudge and it was recognized that he had a personal dislike for Officer Greathouse." See, Bargaining Unit brief, pp. 6-7.

A former Chairman of the Board of Trustees was called as a witness to testify for the Bazetta Township and for the Bazetta Township Board of Trustees. After direct examination of this witness, this witness refused to answer questions on cross examination by the Union regarding Article 11, Section 3 of the CBA. This Article and Section of the CBA is about "seniority".

According to the collective bargaining agreement, "qualifications, education, performance, and experience..." are the factors the Employer must consider when filling a vacant position for the police force. **See, Collective Bargaining Agreement, Article 11, Section 3.** However, if the two applicants were "determined substantially equal, *seniority* will be the determining factor". <u>Id.</u>, *emphasis added*.

This arbitrator finds that both Grievant and Jake Abbott possessed equal qualifications, education, performance and experience to perform the job of sergeant for Bazetta Township, Trumbull County, Ohio. Both were and are excellent law enforcement officers.

However, the Grievant has significantly more seniority than Officer Abbott. Abbott has approximately 10 years while Grievant has approximately 20 years service as a law enforcement officer.

"Seniority" is and has been an important factor in Labor Law. The more time spent as a law enforcement officer makes a better law enforcement officer.

Time spent on the streets and in the courts gives a police officer experience. The more time spent on the streets and in the courtroom, gives a law enforcement officer more experience. This experience may save the life of a citizen as well as the life of an officer. Experience comes with seniority.

In this arbitration, both applicants were well qualified for the sergeant position. Both applicants possess the qualifications, education, performance and experience needed by a police sergeant. This CBA mandates that if both applicants possess substantially equal qualifications, "seniority" is the tiebreaker.

Seniority is a crucial provision of this collective bargaining agreement between the parties. Seniority is the 'tiebreaker' when two qualified police officers are seeking a promotion for the same position. The collective bargaining agreement is clear:

".... Should two (2) or more applicants be determined substantially equal, seniority will be the determining factor....". CBA **Article 11, Section 3.**

Grievant has more seniority than Jacob Abbott.

The employer, Bazetta Township and the Bazetta Township Trustees, breached the COLLECTIVE BARGAINING AGREEMENT, ARTICLE 11, VACANCY AND PROMOTIONS, Section 3 when it failed to award the sergeant position to Grievant, Nathan S. Greathouse.

Jurisdiction to Issue a Remedy

Bazetta Township and the Bazetta Township Trustees argue that no remedy can be provided through the arbitration process. The advocate for Bazetta Township and Bazetta Township Trustees argues that "[t]he Arbitrator does not have the ability to remove Abbott from his position and put Greathouse (the Grievant) into the position of Sergeant." See, Township's Brief, p. 7.

Jacob Abbott is a witness to this arbitration. However, Jacob Abbott is not a party to this arbitration. Abbott's future potential claim(s) or defense(s) is/are not before this Arbitrator.

Grievant's claim is properly before this Arbitrator, and there is a remedy for this violation.

Bazetta Township and/or the Bazetta Township Trustees violated Grievant's contractual rights under the Collective Bargaining Agreement. Bazetta Township and/or the Bazetta Township Trustees violated Article 11, Section 3 of the Collective Bargaining Agreement. Because both Grievant and Jacob Abbott are "substantially equal", seniority should have been "the determining factor".

Grievant was and still is a victim of Bazetta Township and/or the Bazetta Township Trustees. By violating Article 11, section 3 of the CBA, Bazetta Township and/or Bazetta Township Trustees not only violated the CBA by failing to promote the Grievant, Bazetta Township and/or Bazetta Township Trustees has deprived Grievant of the pay that he would have received had he been properly promoted by Bazetta Township and/or the Bazetta Township Trustees.

As each day passes, Bazetta Township and/or the Bazetta Township Trustees continue to deprive compensation from Grievant. This deprivation of compensation from

the Grievant mandates that Bazetta Township and/or Bazetta Township Trustees make the Grievant whole. Requiring Bazetta Township and/or the Bazetta Township Trustees to abide by the Collective Bargaining Agreement is a remedy that can be provided by the arbitration process.

Arbitration Award

This Arbitrator finds that this Employer, Bazetta Township and/or Bazetta Township Trustees, has/have violated the Collective Bargaining Agreement, Article 11, Section 3 of the Collective Bargaining Agreement.

Since both Grievant and Jacob were and are "... substantially equal..." as described in Collective Bargaining Agreement, Article 11, Section 3, Bazetta Township and/or the Bazetta Township Trustees shall promote Grievant to the position of sergeant of the Bazetta Township Police Department. The date of Grievant's promotion is the same date when Jacob Abbott was promoted to the position of Sergeant.

The Employer, Bazetta Township and/or the Bazetta Township Trustees, shall pay Grievant the amount Jacob Abbott was paid as a sergeant less the amount Grievant was paid as a Patrolman, from the date Jacob Abbott started receiving pay as a sergeant until and to the date of this Arbitration Award. At and from the date of this Arbitration Award, the Grievant shall be paid the rate of a Sergeant.

The Grievant shall be made whole because Bazetta Township and/or the Bazetta Township Trustees violated the Collective Bargaining Agreement Article 11, Section 3.
