# Computer Policy, Including Internet Usage and Email

Internet access is provided to individuals based upon business needs to benefit the Township through connection to worldwide information resources. Employees have a responsibility to maintain and enhance Bazetta Township's public image while accessing the Internet by following these guidelines:

Employees using Internet access via our hardware and software are representing the Township. As such, their conduct should be ethical and lawful at all times. Channels may be accessed for official Township business to gain technical or analytical information and to establish business contacts.

Internet access should not be used for personal gain or advancement of personal views, for solicitation of non-township business, or result in the disruption of our organizational network operation or interfere with personal productivity at work.

Employees are responsible for the content of all text, audio, or images they place or send over the Internet. Fraudulent, harassing, or obscene messages are prohibited. All messages on the Internet should be identified with the employee's name. Employees may not obscure the origin of messages and the information published should not violate or infringe upon the rights of others. Abusive, profane or offensive language transmitted through the system is strictly prohibited.

Employees may not download software without the express acknowledgement and support of the IT Specialist to ensure that proper licenses are obtained, and viruses are not transmitted.

Employees may not send or upload any copyrighted materials, trade secrets, proprietary information, or similar materials to third parties. Employees may not violate the copyright laws in regard to receipt/download of materials available on the Internet by copying and disseminating information, except for purposes falling under the category of "fair use".

All messages created, sent, or retrieved over the Internet are the property of Bazetta Township and should be considered public information. We reserve the right to access and monitor all messages and files on the computer system at any time. All communications can be disclosed to law enforcement officials or other third parties without prior consent of the sender or the receiver.

Harassment of any kind is strictly prohibited. Messages with derogatory or inflammatory remarks regarding race, religion, national origin, sexual orientation, or other protected attributes may not be transmitted.

Violations of the Internet Code of Conduct may result in disciplinary action up to and including termination and illegal activities may result in prosecution by legal authorities.





According to Randy Smith it is the time of year to put in our request for salt for 2022/2023 winter season. We still hold 34.18 tons of salt at the county at a cost of \$49.23 per ton or a total of \$1682.68, we are committed to purchase this to clear books from last year first and foremost. Randy and I have no idea of what the forecasted amount per ton of salt is going to run and it has wildly varied over the years. Historically the County Engineers office has always been cheaper for us to co-op through since they go co-op through ODOT.

We have roughly 250 tons of salt left to date from 2021/2022 season. We have used roughly 500 tons during the 22/23 season. We <u>DO NOT NEED</u> to put this on the agenda now, but I need to request a tonnage no later than 4/18/2022, we will also need to remember to approve the tonnage and the amount later in the year when available. I will remind you, but I do need to at least fill this paper out and get it back to the county engineers office with our request, but know that we are bound to this amount.

We have a little over 29K total in license plate tax money (fund 2011) that will also need to have a supplemental appropriation made if permanent appropriations have already been done. We also have 28K in contingency 2021 contracted services. Hopefully per ton costs will be 65-75, but it could be higher with prices of everything else soaring, last years cost was \$49.23 per ton.

My recommendation to the trustees to approve me for a minimum 500 tons for the paperwork to get turned in on time.
