- The Zoning Commission has an upcoming Public Hearing Scheduled for November 1, 2022, on a proposed Zone Change Map Amendment and Text Amendments to the Township Zoning Resolution.
 - The proposed Zone Change Map Amendment involves 60 (sixty) properties in the lvy Hill area. This proposed zone change, if approved, will correct the current zoning designation to comply with the current use, which is Commercial C-3 to Residential R-A. We will also hear the proposed Text Amendments which will add regulations for Solar Panels, Windmills and Electric Vehicle Charging Stations

We will be holding a Special Meeting at 7:00PM, immediately following the Public Hearing, to
discuss and receive input from the affected parcel owners of approximately 13 (thirteen) parcels
on Wilshire Drive. These properties are currently designated Residential R-A, and we are looking
to correct the destination to conform with the current use and destination of the surrounding
parcels

- Stan Shrodek of Lakeshore Drive Is there anything planned from the road department to seal any

 large cracks. Mr. Shrodek suggests having Police presence at Township Hall events or at least the
 police check up on the event. Trustee Hovis explained we do not allow alcohol and we rent it for
 community events
