The Board of Trustees of Bazetta Township, Trumbull County, Ohio, hereby determines to proceed with a levy in excess of the ten-mill limitation, in the amount of 2.0 mills, to be submitted to the electors at the special election to be held on May 2, 2023, and directs the Township Fiscal Officer to certify the required documents to the Trumbull County Board of Elections, all in accordance with the Resolution below.

RESOLUTION NO. 018-23 Fire Department Additional Levy 2.0 Mills

RESOLUTION DECLARING THE NECESSITY TO LEVY A TAX IN EXCESS OF

THE TEN MILL LIMITATION FOR FIRE PURPOSES

WHEREAS, the amount of taxes which may be raised within the ten-mill limitation will be insufficient to provide an adequate amount for the necessary requirements of Bazetta Township Trumbull County, Ohio and it is necessary to levy taxes in excess of the limitation; and

WHEREAS, it is necessary to levy a tax in excess of the ten-mill limitation for the purposes pursuant to Revised Code §5705.19(JJ) to provide funds for the Township Fire Department; and

WHEREAS, on January 10, 2023, the Board of Trustees passed and adopted Resolution 18-23 declaring the necessity of levying a tax outside the ten-mill limitation for the benefit of the Township Fire Department, and the Fiscal Officer certified the Resolution to the County Auditor; and

WHEREAS, on January 12, 2023, The Auditor provided the Township a Certificate of Estimated Property Tax Revenue, certifying that:

- 1) The property tax revenue that will be produced by the stated millage, assuming tax valuation of the subdivision remains constant throughout the life of the levy, is calculated to be \$333,470.00.
- 2) The total tax value of the township is \$166,735,050.00; and
- 3) The millage is 2.0 mills for each \$1 of taxable value, which amounts to \$70.00 for each \$100,000 of the county auditor's appraised value.

NOW THEREFORE BE IT RESOLVED, by the Board of Trustees of Bazetta Township, Trumbull County, Ohio, all members elected thereto concurring, that the Board desires to proceed with the submission of the question of an additional levy in excess the ten-mill limitation for the benefit of Bazetta Township Fire Department as follows:

- 1) The proposed rate of the tax shall be 2.0 mills for each one dollar of taxable value.
- 2) The purpose of the tax shall be:

For providing and maintaining fire apparatus, mechanical resuscitators, underwater rescue and recovery equipment, or other fire equipment and appliances, buildings and sites therefor, or sources of water supply and materials therefor, for the establishment and maintenance of lines of fire-alarm communications, for the payment of firefighting companies or permanent, part-time, or volunteer firefighting, emergency medical service, administrative, or communications personnel to operate the same, including the payment of any employer contributions required for such personnel under section 145.48 or 742.34 of the Revised Code, for the purchase of ambulance equipment, for the provision of ambulance, paramedic, or other emergency medical services operated by a fire department or firefighting company, or for the payment of other related costs.

- 3) The tax is an additional levy.
- 4) The sections of the Revised Code authorizing submission of the question of the tax are: R.C. §505.37, R.C. §5705.19(I) and R.C. §5705.191.
- 5) The tax is for a continuing period of time.
- 6) The tax is to be levied upon the entire territory of Bazetta Township.

- 7) The ballot measure shall be submitted to the entire territory of Bazetta Township.
 - 8) Bazetta Township is wholly located in Trumbull County, Ohio.
- 9) The date of the election at which the question of the tax shall appear on the ballot is May 2, 2023.
- 10) The tax year in which the tax will first be levied is 2023 and the calendar year in which the tax will first be collected is 2024.

BE IT FURTHER RESOLVED that the form of ballot to be used for submitting the question of such additional tax levy to the electors of Bazetta Township, Trumbull County, Ohio, and cast at the election, shall be in conformity with all provisions of law and/or as follows:

"An additional tax for the benefit of Bazetta Township, Trumbull County Ohio, for the purpose of providing for the Township Fire Department, by providing and maintaining fire apparatus, mechanical resuscitators, underwater rescue and recovery equipment, or other fire equipment and appliances, buildings and sites therefor, or sources of water supply and materials therefor, for the establishment and maintenance of lines of fire-alarm communications, for the payment of firefighting companies or permanent, part-time, or volunteer firefighting, emergency medical service, administrative, or communications personnel to operate the same, including the payment of any employer contributions required for such personnel under section 145.48 or 742.34 of the Revised Code, for the purchase of ambulance equipment, for the provision of ambulance, paramedic, or other emergency medical services operated by a fire department or firefighting company, or for the payment of other related costs, that the county auditor estimates will collect \$333,470 annually, at a rate not exceeding 2.0 mills for each \$1 of taxable value, which amounts to \$70 for each \$100,000 of the county auditor's appraised value, for a continuous period of time, commencing in January 2023 and first due in calendar year 2024.
