In the matter of the proposed Joint Land Use Study for the Military Installation Sustainability Project, also known as the YARS Overlay to our Comprehensive Plan and Zoning Resolution, that was submitted to our Board by the Trumbull County Planning Commission and the Youngstown Air Reserve Station:

The Zoning Commission has developed the attached list of concerns as a result of three meetings (one with Julie Green), numerous phone calls with the Trumbull County Planning Commission, community input and many hours of commissioner's research and discussion.

It is for these concerns we would like to inform you at our recent Special Meeting on April 17, 2023, the Zoning Commissioners moved to TABLE the proposal at this time. We feel it would be irresponsible to make a motion of recommendation (of any kind) by resolution to the Board of Trustees until the concerns of the residents are addressed and the proposal is reviewed by legal counsel.

YARS OVERLAY - LIST OF CONCERNS

- 1. Resident pushback (Residents stated they all support the Air Base however they have the following concerns)
 - Land use restrictions for current use even after grandfathered in
 - Economic growth impact property value loss
 - Resale value is extremely restricted to potential buyers
 - No benefit to the residents or township as a whole if accepted
 - Taxpayers do not want to spend tax dollars on this
 - They have lived with the airbase for 72 years, why push restrictions on them now?
 - Will restrict housing and business development
 - If adopted as written, going forward, they will have to go before the Appeals Board to improve their property for something they have the right to now. If denied, they will have to seek other legal options
 - BASH zone is redundant as we are a lake community with a wildlife preserve
 - Questioned why the Army Corp of Engineers and Mosquito State Park were not consulted
 - Drones use and height requirements are already governed
 - Residents pay the taxes. How much tax revenue comes from the Air Base?
 - Commercial business owners have owned and operated these businesses for over 50 years and are concerned for the future generational growth and livelihood
 - Residents expressed they do not want to adopt any of the proposal
- 2. Zoning Commissioners Concerns
 - We have limited funds in our budget. Legal advice on such a large proposal will be very expensive (Legal Counsel) to evaluate the impact of the proposed changes
 - Julie Green advised there were no funds set aside for the political subdivisions to cover procedural and legal expenses through her grant
 - Per Julie Green: Trumbull County Prosecutor's Office has not reviewed the proposal
