Our current Official Zoning Map was last updated and approved by the Board of Trustees in 2010.

The Bazetta Township Zoning Inspectors have been working with the Bazetta Township Zoning Commission and the Trumbull County Planning Commission on updating it since October of 2022. Due to staffing, scheduling, and other factors, it has taken a while to accomplish the update.

All of the Zone Changes on record with the Trumbull County Recorder's Office available to us, all the records available to us here at the Administration Office, those the Trumbull County Planning Commission hold, Amendments listed in our Zoning Resolution, current land use, grandfathered land use and non-conforming land use were all taken into consideration to update the map from 2010. The Trumbull County Planning Commission prepared drafts, and our Commissioners and Inspector made corrections and changes as needed. A final draft is what is presented here to you today.

On September 3, 2025 the Bazetta Township Zoning Commission held a Public Hearing to consider the updated map and it was passed unanimously by Motion No. 014-25 and transmitted to the Board of trustees for our action.
